W.T. 100 BOARD OF DIRECTORS BUDGET MEETING THURSDAY, DECEMBER 22, 2016 AT 7:00 P.M. AUDITORIUM

IN ACCORDANCE TO OUR DOCUMENTS AND HAVING DULY POSTED NOTICE OF A BOARD OF DIRECTORS MEETING, MEETING CALLED TO ORDER AT 7:00 P.M. ROLL CALL TAKEN AND NORMAN PESELEV, SLAVA BUTLER, ELIZABETH KLEIN, GENNADY SEDIKOV, AARON ALTHEIM WERE IN ATTENDANCE. A QUORUM WAS DECLARED AND MEETING COMMENCED.

NORMAN PESELEV MADE A MOTION TO WAIVE THE READING OF THE MINUTES OF FEBRUARY 4, 2016, SECONDED BY SLAVA BUTLER, AND MOTION UNANIMOUSLY APPROVED. NORMAN PESELEV MADE A MOTION TO VOTE TO APPROVE THE MINUTES OF FEBRUARY 4, 2016 SECONDED BY SLAVA BUTLER, APPROVED UNANIMOUSLY.

NORMAN PESELEV GAVE EXPLANATION OF THE 13TH MONTH ASSESSMENT, THAT THE BUILDING HAD SEVERAL EMERGENCY PROJECTS THAT NEEDED TO BE DONE. THIS EMERGENCY REPAIRS WERE NOT PART OF THE BUDGET OR THE SPECIAL ASSESSMENT THAT WAS COLLECTED IN 2015. EMERGENCY REPAIRS:

- 7. TRASH ROOM GUILLOTINE/FIRE DISCHARGE DOOR
- 8. DRYER EXHAUST CLEANING
- 9. GARAGE DOORS
- 10. FIRE ALARM SYSTEM REPAIR

TOTAL EMERGENCY REPAIRS COST \$133,026.00

THE BOARD THEN REVIEWED THE ABOVE EMERGENCY REPAIR COST AND ANALYZED SAME BY COMPARING THE ADDITIONAL CHARGES OF WORK DONE IN AN ALTERNATE MATTER, INCLUDING:

- COST OF BUILDING MANAGER WHICH WOULD OTHERWISE BE PART OF SUCH COST;
- B. COST OF PROJECT MANAGER WHICH WOULD ALSO BE PART OF SUCH COST;
- C. OTHER CONSULTANT COSTS THAT WOULD BE PART OF SUCH COST; AND
- D. TIME DELAY TO BE INCURRED IN EVENT OF OTHER ALTERNATE ACTION.

AS A CONSEQUENCE, THE BOARD EVALUATED ALL FACTORS AND FOUND THAT THE BEST COURSE OF ACTION WAS AN ADDITIONAL ASSESSMENT FOR THE YEAR (I.E. 13TH ASSESSMENT) BE COLLECTED IN THE TOTAL AMOUNT OF \$137,074.00

NORMAN PESELEV GAVE THE TREASURER'S FINANCIAL REPORT.

NORMAN PESELEV MADE MOTION TO RATIFY AND ADOPT SPECIAL ASSESSMENT TO PAY FOR SHORTFALL AS PROJECTED UNDER BUDGET OF 2016 WHICH REQUIRED ADDITIONAL ASSESSMENT BUT IS NOW TO BE IMPOSED IN LIEU OF ADDITIONAL 13TH ASSESSMENT, SECONDED BY GENNADY SEDIKOV, AND MOTION UNANIMOUSLY APPROVED.
