**TAURUS CHUTES** Remove existing trash chute from 18<sup>th</sup> Floor through Discharge room. **TWENTY-TWO (22)** Floors total.

- Replace damaged materials (Per Building Code 502.1) with brand new, custom made, 16-gauge Aluminized steel trash chute 24" diameter
- PH, 22<sup>nd</sup>, 21<sup>st</sup>, 20<sup>th</sup>, 19<sup>th</sup>, 18<sup>th</sup>, 17<sup>th</sup>, 16<sup>th</sup>, 15<sup>th</sup>, 14<sup>th</sup>, 12<sup>th</sup>, 11<sup>th</sup>, 10<sup>th</sup>, 9<sup>th</sup>, 8<sup>th</sup>, 7<sup>th</sup>, 6<sup>th</sup>, 5<sup>th</sup>, 4<sup>th</sup>, 3<sup>rd</sup>, 2<sup>nd</sup>, 1<sup>st</sup> and Basement Floor will include new intakes, chute sections, new steel floor supports and new Doors.
- **TWENTY-ONE (21)** Floors will include new Doors Size 15X18 B/H. All doors shall be hand operated, self-closing, positive self-latching and bottom Hinge with 1-1/2-hour 250 degree "UL" label, in Stainless Steel No. 3 type finish. Each door shall be equipped with Handle with 2 keys. This is the superior guality, longer lasting, easy cleaning, and low maintenance.
- TWENTY-ONE (21) Floors (PH Floor through 1<sup>st</sup> Floor) will include New intakes and New Floors supports (if required).
- One **(1)** Floor will be Straight section from bottom of **1**<sup>st</sup> Floor down to Dumpster.
- Straight section will be inserted inside on last chute portion to existing vent. Final section will meet Building Code 2017/ Existing Building, Section 502.
- Discharge: Open-End "Accordion Damper Assembly", interlocking type blades or (HRD) "Horizontal Rolling Discharge" fabricated from 3/16" galvanized steel, and equipped with UL Fusible link for automatic closing with heat rising above 165 °F.
- Trash chute repairs to be installed in accordance with Florida Building Code 2017/ Existing Building, Section 502. Trash Chute doors to be installed in accordance with NFPA-82.

#### Scope of Work

# First Week. Design architectural plans and Approval the new chute (Engineering Drawing) Demolition and removal of existing Walls. Cutting and Removal of existing (Old) Trash Chute. Safely Removal and deposing trash from material cut off and/or Construction material.

Next Two Weeks.
 Install New Supports frames for the new trash chute.
 Install New Intakes
 Install, Connect and Mechanically lock-seamed new sections and Intakes.

First a Rough Inspection & Approval by the CITY INSPECTOR. (Confirm his/her Availability)

#### • Final Week.

Install and Finish New Walls (Fire rated) Install New Doors (Self-Closing) Culminating with a Final Inspection by the CITY INSPECTOR. (Confirm his/her Availability) Finally-Cleaning, Inspecting and turnkey the Job.

- After chute replacement and approval, we will replace walls with 2 Hour Fire rated cement block or Durock Cement Board. Walls will be ready to be paint, **but NOT painted (No finish).**
- **Price shown DOES NOT INCLUDE** disconnection/reconnection of any attached Fire Sprinkler system line(s). Wayne fire sprinklers is recommended by Taurus Chutes to perform this scope of work.
- Taurus Chutes, Inc. <u>WILL</u> arrange for Building permit. Permits and permits cost and <u>NOT INCLUDED</u> in the price.

- This proposal **does not** include the cost of fire alarm disconnections or reconnections as this work must be performed by licensed fire safety company. Taurus Chutes Inc. can arrange for this work to be done at the Property's expense.
- ➤ This proposal DOES (or) DOES NOT √ include the cost of Building & Mechanical Permits & NOC. Taurus Chutes WILL arrange for the necessary permits.
- > This proposal does NOT include the cost of moving the compactor if this is required. (NOT APPLICABLE FOR THIS JOB)
- This job carries a One-year warranty for both material and labor, under normal usage, with aluminized steel chute, under normal usage and with Annual Maintenance.
- Taurus Chutes WILL VILL NOT provide Rubbermaid-type garbage pails in each trash room, for resident's convenience while chute closed. Property is responsible for emptying pails.
- Taurus Chutes will attempt to leave the work area(s) swept and clean of debris each day. However, dust is inevitable please be understanding while we work.
- Taurus Chutes will endeavor to protect the floors, elevators, walls, etc. from damage. However, we recommend that you cover carpets, marble floors, etc., while construction is ongoing.
- We will provide a dumpster for construction debris if needed, EXCEPT in Miami-Dade County. For projects in Miami-Dade County, property must make arrangements with their trash collection company to supply a dumpster for construction debris.
- Taurus Chutes does not anticipate any additional work that is detailed out of the scope of work provided which will increase the price. If any problem will arise after opening entrance walls, Taurus Chutes will not be responsible for an existing damage.

- The initial deposit is refundable if Customer cancels or substantially changes the project within One Month of signing the contract. All expenses incurred will be deducted. After One Month Fifty Percent (50%) of the deposit will be withheld to cover material & permit costs & any other expenses.
- The Price and Terms of this contract are NOT considered binding to either party until this signed proposal and Twenty Five percent (25%) deposit are received by TAURUS CHUTES INC.
