- 3. Total accounts receivable is approx. \$199k, with an establish allowance for uncollectible accounts of approx. (\$191k).
- 4. Annual insurance premiums renewed 5/26/23 and are financed through First Insurance Funding. The balance due as of this period is approx. 1k [GL2501].
- 5. Association contracted a loan with CIT to finance the Special Assessment project in the amount of \$1,700,000 with a maturity date 04/20/26. The CIT Loan was later acquired by Truist in June 2022 set at 5.25% maturity date 06/25/2027. The balance due as of this period is approx. \$9.08M [GL3125].
