Description

PROPOSAL FOR TRASH CHUTE REPLACEMENT...

Remove existing Trash Chutes from floor PH through Dumpster/Compactor room: 22 floors total PER CHUTE

Replace with brand-new, custom-made, 16-gauge Aluminized Steel Trash Chutes; 24" diameter.

20 floors per chute (floors 2 through PH) will include new Intakes and new Floor Supports.

20 floors per chute will include new self-closing, self-latching, stainless steel, 1.5 hour UL-rated Chute Doors. Size BHU1518

One (1) floor will be Straight Chute from Floor 2 to Dumpster/Compactor room.

In each Dumpster/Compactor room, at end of Trash Chute, install new, Rolling-style Discharge Door, equipped with UL-listed Fusible Link. Discharge Door will be fabricated of 10-gauge galvanized steel.

Wherever necessary, fabricate and install Elbow(s) to direct garbage into Dumpster(s)/Compactor(s). Elbow(s) will be fabricated of 16-Gauge Galvanized Steel and will be double-reinforced at impact points.

Install a metal Fire Stop shield collar where Chute enters Dumpster/Compactor room at the ceiling.

Southern Chute Inc will be responsible for the removal of the walls located in trash rooms on 20 floors per chute; from floor to ceiling, and approximately 30" wide, to gain access to trash chute.

After chute replacement and inspection, we will replace walls with 2 Hour Fire Rated cement block: walls will be paint-ready, but not painted. Smooth stucco finish is available at additional cost. Replacement of decorative trim, wallboard, etc is NOT included.

Southern Chute is a state licensed contractor and will arrange for Building Permit. Permit cost is determined by Building Department at time of application submission. Permit cost and costs associated with obtaining Permit (such as notary stamps, architectural plans, permit runners, etc) are not included in price below and will be billed separately on final invoice.
